Beach & Natural Resource Protection

The purpose is to codify, into one chapter, the State of Georgia regulations that apply to the Jekyll Island State Park including:

- » Regulations for the use of the beaches on Jekyll Island.
- » Regulations on protection of wildlife within the State Park.
- » Establishes a special permitting process if someone wishes to request an exemption to these rules.





Sea Level Rise Resilience





Sea Level Rise Resilience

- » Adapted from the guidance document, Enhancing Coastal Resilience with Green Infrastructure by CRD & UGA Carl Vincent Institute.
- » Recommended for adoption in Jekyll Island Conservation Plan, 2021 Jekyll Island Master Plan, and the Glynn County Sea Level Rise Response and Implementation Plan.
- » SLR projections to be used for policy, planning, design, and regulatory purposes.
- » Creates a 75-Ft buffer around tidally influenced waters for new buildings and infrastructure.
- » The buffer will not impact maintenance, repair and renovation of existing structures and infrastructure.





Commercial & Business Regulations





Commercial & Business Regulations

- » Clarifications to the existing language from the current Code.
- » Brings the existing project review process from the informal design guidelines into the Code. The steps include,
 - » Site Visit & Pre-Concept Meeting,
 - » Schematic Design,
 - » Landscape Plan including designation of Tree Protection Areas,
 - » Design Development and
 - » Construction Site Visits and Inspections.
- » Use and design standards including height, parking, public spaces and lighting.
- » Incorporates the complete alcohol regulations into the Commercial chapter.
- » Regulations for trash compactors and fats, oils and grease disposal for commercial users.





Animal Control





Animal Control

» Consolidated existing codes addressing domestic animals and pets into one chapter.

» The current Jekyll Code references impoundment of animals and kennels. Since Glynn County Animal Control handles this, the code is updated to reflect actual practice.





Historic Preservation





Historic Preservation

- » The Jekyll Island Club Historic District was added to the National Register of Historic Places on January 20, 1972 & designated a National Historic Landmark District on June 2, 1978.
- » This long-established historic district is protected under guidelines and procedures that have been in place for decades.





Historic Preservation

- » Authority management is proposing that a historic resource study be conducted during FY23 which will evaluate the mid-century modern homes located throughout Jekyll Island.
- » The results of this study, along with future public discussions on the appropriate historic preservation strategies for Jekyll Island, will provide a stronger foundation for any new policies for the protection, enhancement and use of historic properties and sites on Jekyll Island.
